## THE FOUNDATION

The First Baptist Church of Roswell Foundation was formed in 2007 to provide members and friends the opportunity to preserve the mission and ministries of the church.

### Why consider a gift to the Foundation?

### How do I distinguish a gift to the Foundation?

Donations intended for the First Baptist Church of Roswell Foundation should be specifically indicated. The First Baptist Church of Roswell Foundation operates separately from First Baptist Roswell church.

### How are foundation gifts managed?

All foundation dollars are invested to generate interest and only a portion of this interest income is utilized for grant purposes, thus ensuring that gifts grow over time.

### How are dollars used to support the ministry and missions of the church?

A portion of interest income is used to supplement the many ministries of the church and provide additional resources where needed most.
