Registration fee for all Preschool/Kindergarten/Pre-First/MMO students is \$100 (second child - \$75). This registration fee is NON-REFUNDABLE and must accompany the application. There will also be a supply fee due in August and January for all students. Tuition is due on the 1st of each month, including August. A late fee of \$10 per transaction will be charged after the 10th of each month.

Withdrawal: Written notice is to be given to the preschool office, thirty days prior to withdrawal.

Tuition/Lunch Bunch: No refunds will be made for short or long absences. This includes sick days, holidays and vacations.

Lunch Bunch 2025/2026:

***No refunds will be made for short or long absences. This includes sick days, holidays and vacations.

- December and May Lunch Bunch will be prorated at ½ off.

Per Month:

- 1 day a week - \$28.00
- 2 days a week - \$56.00
- 3 days a week - \$84.00
- 4 days a week - \$112.00

Supply fees: \$50 per student due in **August and January**.

Kindergarten and Pre-1st one-time book fee: \$75.

ADMISSIONS

First Baptist Church – Roswell Preschool/Kindergarten/Pre-First/MMO accepts applications for enrollment on the following basis:

1. First consideration is given to the students currently enrolled in the school.
2. Applications are then accepted for the remaining places in the classrooms on a first-come basis.
3. First Baptist Roswell Preschool/Kindergarten/Pre-First/MMO strives to accommodate children with varying abilities, but whose potential achievement is not incapacitated by special learning disabilities, emotional disturbances, hyperactivity, behavior problems or severe orthopedic, visual or hearing disabilities. FBRK is limited in professional staffing prepared to give assistance to children with the above-described conditions. Any difficulties with which the school should be cognizant must appear on the registration form. The presence of conditions does not mean that admission will not be granted, rather the school board must determine if staffing, organization and finances are available to meet the child's needs. Parents may be asked to assist in the financial responsibility of additional personnel. If our preschool cannot meet the needs of a child, we reserve the right to discontinue enrollment of said child.
4. **Potty Trained** - Children attending the Two-Year-Old Preschool Class must be **fully potty trained by their first day of school**—no exceptions. For all children ages **three and older, full potty training is required at the time of registration**, with no exceptions. Our preschool area does not have diaper-changing facilities. When registering your child, please ensure they are placed in the appropriate classroom based on their age and potty-training status. Our classrooms fill quickly, and it is essential that each child is placed in the correct class. If a child is assigned to a classroom but is not yet fully potty trained, we will need to explore other options, including possible transfers, depending on availability. For children who are not yet potty trained, we offer an MMO Toddler Class at FBRK, which is designed for two-year-olds who have not yet begun potty training.
5. Enrollment at FBRK is not limited to any race or national origin. It is the desire of FBRK to meet the development levels of all students, and to maintain appropriate student-teacher ratios.
6. Class enrollment is on a first-come, first-serve basis. Adjustments may be made to maintain the distribution of boys and girls in the class. (This includes a waiting list.) Other adjustments may be made to meet the needs of the individual students and the obligations of the school.
7. If there are any custody issues or a pending/final divorce arrangement, involving a child seeking acceptance to FBKR, all legal/binding custody agreement documents must be on file, before the child may attend school.
8. Thirty-day notice must be given upon withdrawing your child from FBKR, or a month's tuition must be paid.
9. FBRK has my permission to use my child's photograph for classroom/school print or electronic use (classroom social media/online portal).
10. I have read, understand and agree with the terms in the Policy and Procedure Handbook (Our School Hangout Portal).

In making an application for my child, I have read and understood the custody document requirement, potty training, tuition and fee payment schedule and have been given a copy at registration.
